

Rules governing non-allocated capacity auctions

- 1. The subject of the auction is the amount of the increase of the basic fee for train paths for which it is not possible to meet the requirements defined in the applications submitted due to the overcrowding of the infrastructure section specified in the invitation to participate in the auction, according to specimen No. 1, constituting an annex to these rules.
- 2. The organizer of the auction is the Centrum Zarządzania Ruchem Kolejowym PLK [Railway Traffic Management Centre of the PLK], which appoints the team to hold non-allocated capacity auctions. The chairperson of the team for holding non-allocated capacity auctions is an employee appointed by the director of the Centrum Zarządzania Ruchem Kolejowym PLK [Railway Traffic Management Centre of the PLK].
- 3. Duties of the auction holder cover in particular:
 - 1) verification of the presence of interested applicants and the authorizations provided;
 - 2) characterize the situation arising after completion of the co-ordination process on a section of a railway line considered as overfilled;
 - 3) determination of the basic fee increase amount declared by applicants for individual train paths;
 - 4) indication of the order in which applications for capacity allocation for train paths are considered;
 - verification of the annual timetable draft for unallocated capacity, taking into account the new order of processing the applications covered by the auction;
 - 6) determining the amount of the basic fee increase for train paths for which, as a result of the auction, it is possible to limit the derogations from requirements specified in the application in relation to the annual timetable draft;
 - 7) providing applicants with a new proposal for paths requested on an overcrowded infrastructure section, including alternative or variant paths, or refusing to allocate capacity;
 - 8) determination of applicants to whom train paths are allocated to and the amount of the basic fee increase.
- 4. The applicants interested in using the overcrowded railway infrastructure, who have submitted equivalent requests for train path allocation, under the priorities listed in Paragraph 7 point 7 of the Regulation are invited to participate in the auction, after the process of coordination of applications for allocation of train paths.
- 5. The condition for admission of an applicant to the auction is presentation to the auction organizer, prior to the auction commencement, of an authorization to represent the applicant drawn up in accordance with specimen No. 2, constituting an annex to these rules.
- 6. The auction is held at the place and time specified in the invitation to participate in the auction.
- 7. The auction is conducted only with the participation of the invited applicants. Written offers will not be considered.
- 8. The auction involves an oral auction of the amount of the base fee increase for individual train paths, according to submitted applications for capacity allocation subject to auction.
- 9. The minimum bid amount raise is PLN 10 (excluding VAT).
- 10. The end of auction is preceded by a three-fold confirmation by the auctioneer of the last raised bid amount for the basic charge for a particular path.
- 11. The applicant, in case of receiving a new path proposal, referred to in clause 3 pt. 7, within 5 working days of its receipt can withdraw applications for which the annual timetable draft does not meet requirements specified in the application. Lack of withdrawal of applications by the applicant is equivalent to the acceptance of the proposal referred to in para. 3 pt. 7.

- 12. The auction organizer shall draw up, according to specimen No. 3, constituting an annex to these rules, a report of the course of the auction with the indication of the applicant to whom the free capacity is allocated. The auction report should be signed by representatives of the auction organizer and representatives of the applicants.
- 13. Auction participants can submit comments on the auction in the auction report.
- 14. The auction report is passed to all applicants participating in the auction.
- 15. Complaints concerning the auction should be submitted no later than 3 days after receipt of the auction report to Centrum Zarządzania Ruchem Kolejowym PLK [Railway Traffic Management Centre of the PLK].
- 16. The amount of the increase of the basic fee for the passage on the overcrowded railway infrastructure in the period of overcrowding, set under point 11, will be included in the Usage Agreement.
- 17. Additional information about the auction is provided by the auction organiser mentioned in the invitation referred to in point 1.
